

CHILD CAR SEATS

UNTIL A CHILD REACHES 14 YEARS OLD
IT IS THE DRIVER'S LEGAL RESPONSIBILITY TO ENSURE
THAT THE CHILD IS CORRECTLY RESTRAINED



Children must use the correct child car seat until they are 12 years old or 135cm tall whichever comes first.



If the child is 12 years old or more than 135cm tall they must use a seat belt.



CHOOSE A CHILD CAR SEAT BASED ON THE CHILD'S HEIGHT OR WEIGHT

WEIGHT-BASED SEATS

These relate broadly to different age groups but it is the weight of the child that is most important.

Weight-based seats must have a label showing a capital 'E' in a circle and 'ECE R44'.

While it is legal under the current regulation (R44.04) for children to use a forward-facing Group 1 seat when they weigh 9kg or more, it does not offer the child the best protection. It is recommended to keep the child rear-facing for as long as possible.

GROUP 0

0 to 10kg (22lb)

GROUP 0+ 0 to 13kg (29lb) Rear-facing

GROUP 1

9 to 18kg (20 to 40lb)

Rear/forward-facing

GROUP 2

15 to 25kg (33 to 55lb)

GROUP 3

22 to 36kg (48 to 79lb)

High-backed booster seat or booster cushion



You may be able to choose a combination seat which covers more than one group.

A booster cushion, without a back or side wings, is not recommended as it removes side and head protection from the child car seat.

HEIGHT-BASED SEATS

These focus on the child's height. Ensure that the child's height is within range of the seat that you intend to use.



Height-based seats must have a label showing a capital 'E' in a circle and 'R129'.

The child must be rear-facing until they are over 15 months old, but it is recommended to remain rear-facing as long as possible as this offers greater protection.

Height-based child car seats displaying an 'i-size' logo are compatible with 'i-size' certified vehicles.

ENSURING THE CORRECT FIT

NOT ALL CHILD CAR SEATS FIT ALL VEHICLES
CHECK COMPATIBILITY ON THE CAR SEAT MANUFACTURER'S WEBSITE

ISOFIX



ISOFIX secures the child car seat (or seat base) to two metal anchor points built into the vehicle.

Using ISOFIX makes it easier to fit a child car seat and can reduce the risk of it being fitted incorrectly.

If the vehicle or child car seat are not compatible with ISOFIX it is possible to secure the seat using the seat belt.

There will be a label on the side of the seat showing how it should be fitted but also read the instructions carefully.

If the child seat has a supporting leg, the leg should be adjusted for height so that the seat is braced against the floor. A green indicator may be visible when set correctly.

USING THE HARNESS OR SEAT BELT

The harness must be correctly adjusted so that the child is secure; the instruction manual should help with this.

It is important to perform regular checks and adjustments of the straps as the child grows.

The harness should fit securely, with just enough gap to fit one or two fingers between the child's chest and the harness, making sure it also lies flat and is not twisted.

When a seat belt is used to secure the child, there should be a slot or indicator on the seat to show where the belt should go.

The seat belt needs to sit across the child's pelvis, chest and shoulder.

Remove thick jackets so that the harness or seat belt can be tightened properly to protect the child in the event of a collision.

Some children may attempt to remove the harness or seat belt. Although accessories are available to purchase, any device that impacts how the seat belt, harness or buckle works are not recommended.

OTHER POINTS TO CONSIDER

CHILDREN WITH ADDITIONAL NEEDS

Children with medical conditions or disabilities must still use a child car seat or seat belt unless an exemption certificate is issued.

A doctor will be able to provide more information and can issue an exemption certificate if a child is unable to use a restraint or seat belt.

A specially adapted child car seat or seat belt can be used if necessary but devices should not be adapted without seeking expert advice.

AIRBAGS

Never fit a rear-facing child car seat in the front of a vehicle if there is an active passenger airbag.

Children should travel in the rear if possible.

Only fit a forward-facing child seat in the front if there is no other option.

If you must do so, ensure that the vehicle seat is set as far back as possible.



PURCHASING A CHILD CAR SEAT



Consider purchasing from a retailer that will allow you to test-fit the seat in your vehicle and check if they are compatible.

Check if staff members have been trained to fit child car seats and ask them to demonstrate installing and removing the seat, along with any additional features it may have.

If there is not a trained member of staff available to assist, find out if it possible for you return the car seat if it is not suitable.

If you intend to use a child car seat in more than one vehicle, ensure that the item you purchase fits correctly in each vehicle.

Check that the child car seat will fit in each of the seat positions that you intend to use it in.
